



In 2013 Det. Supt. Claire Armes had knowledge that a false entry had been placed on the Devon and Cornwall Police log by PC 2631 Emma Pack <u>now</u> PC 2631 Emma Storey-Barrett. Det. Supt. Claire Armes and Det. Supt. Sam De Reya failed to disclose this information to Thames Valley Police.



Hospital Medical Director Report reference: Pilot Leonard Lawrence:

- 1. <u>He was then medicated to the extent that he lost mental capacity</u>.
- During the period the Official Solicitor of the Supreme Court acted as his Guardian ad Litem, <u>three Court of Protection medical certificates</u> (CP3s) had been obtained but not registered with the Court of Protection.
- 3. He was, therefore, for nearly 18 months regarded as a mentally ill patient without access to the Court of Protection. During this time considerable amounts of his assets went missing.
