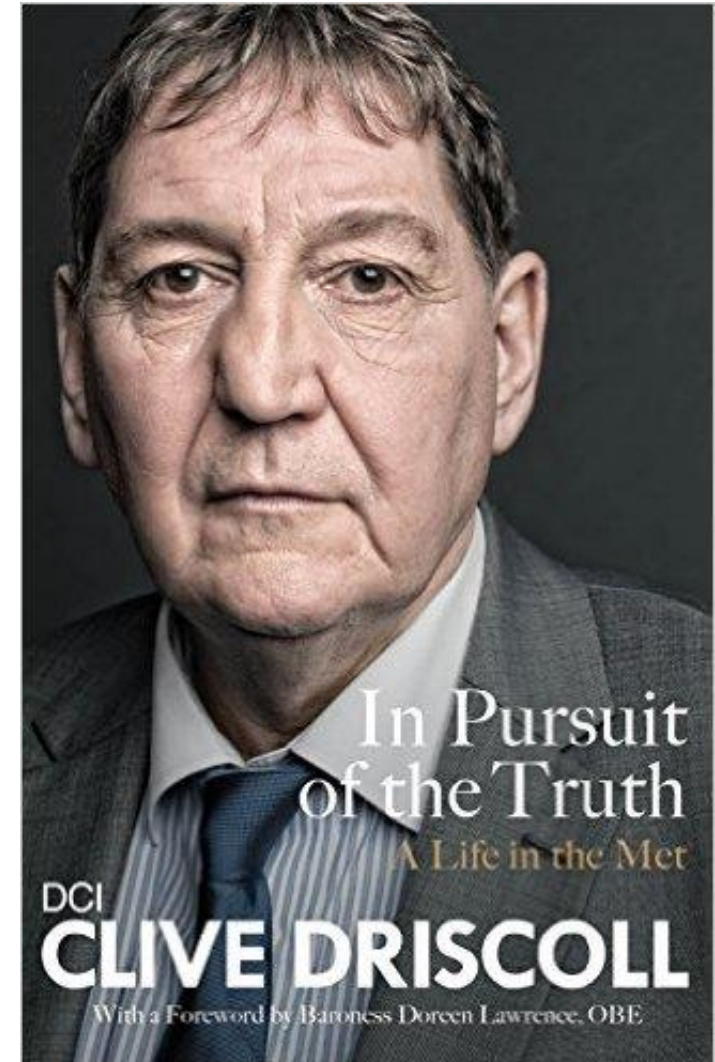

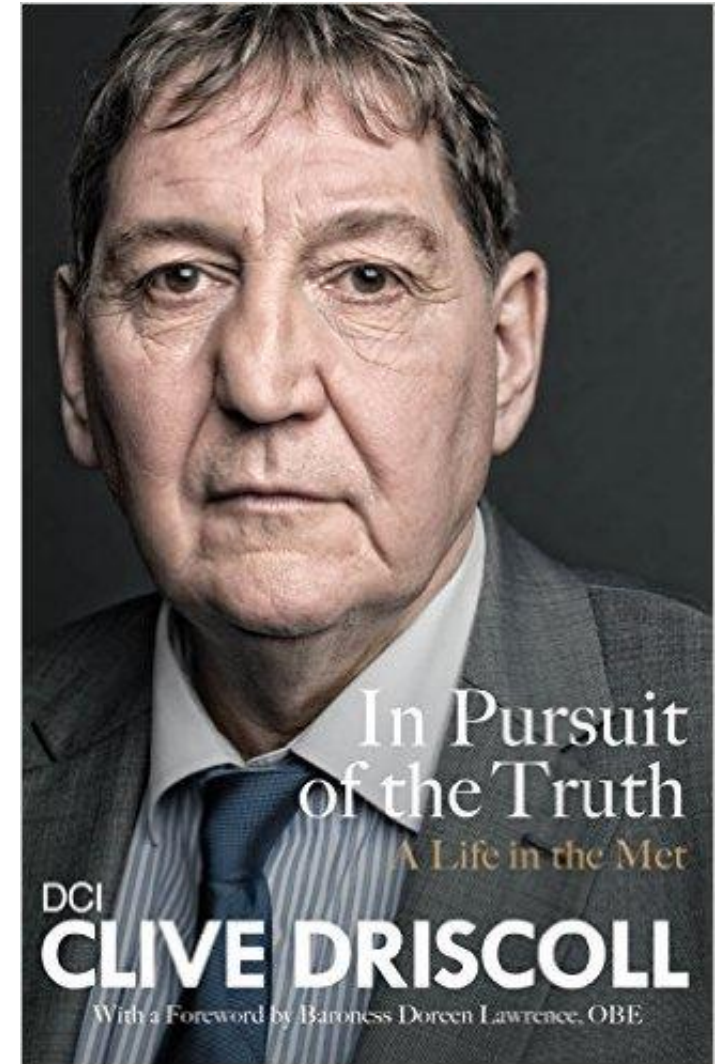

# Detective Superintendent Claire Armes

## Force Intelligence Officer, Devon & Cornwall Police



In 2013 Det. Supt. Claire Armes had knowledge that a false entry had been placed on the Devon and Cornwall Police log by PC 2631 Emma Pack now PC 2631 Emma Storey-Barrett. Det. Supt. Claire Armes and Det. Supt. Sam De Reya failed to disclose this information to Thames Valley Police.

In 2015 another Police Force identified offences of fraud, and other more serious offences including perjury, against Leonard Lawrence and directed Devon and Cornwall Police to take a statement. The matter was assigned to the Serious and Organised Crime Unit, Devon and Cornwall Police.

The move was opposed by 254 Conservative and 40 Liberal Democrats

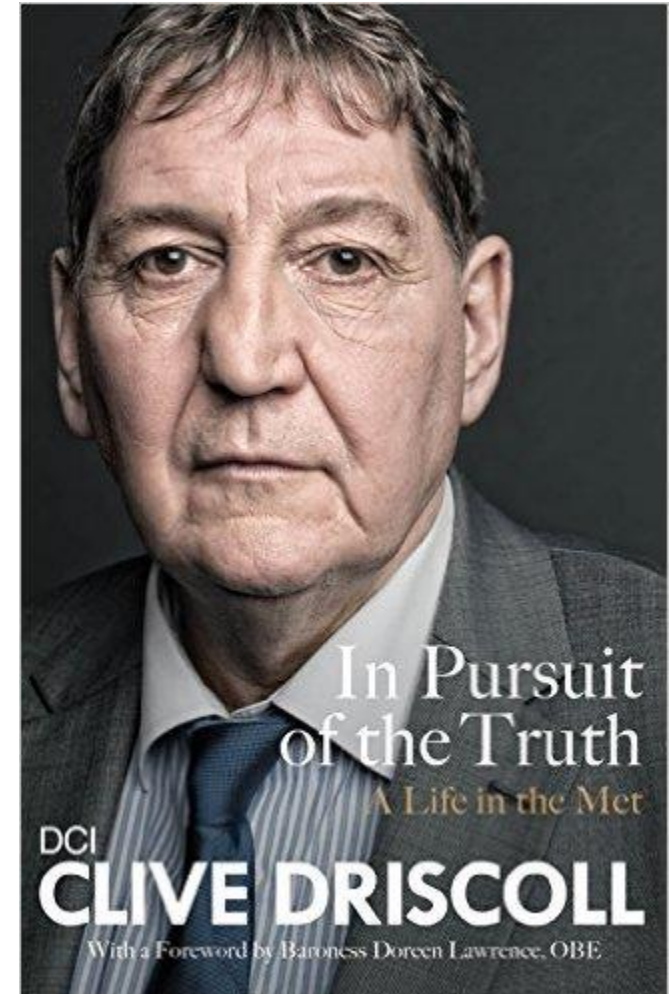

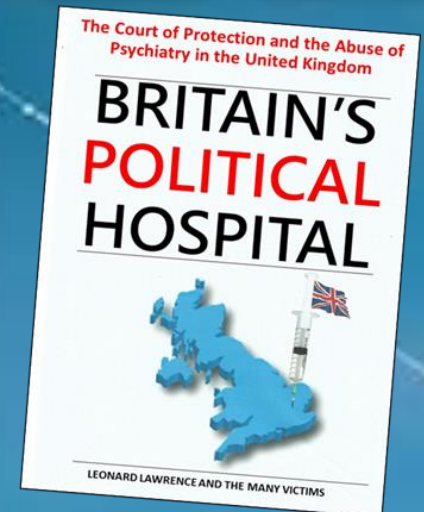

# The Court of Protection

## Mr Justice Peter Jackson, Court of Protection Judge

The latest judicial condemnation came in *C v Blackburn with Darwen Borough Council* [2011] EWHC 3321 (COP) where Mr Justice Jackson stated that: "It is a truly unhappy state of affairs that the law governing the fundamental rights and welfare of incapacitated people should be so complex. As this case shows, its intricacies challenge the understanding of professionals working in the field and are **completely inaccessible to those for whose benefit the legislation has been devised**, including those with a relatively high level of understanding, such as Mr. C."

## The Rt Hon. the Lord Hardie QC

“We were very concerned by what we heard about the safeguards.

**The evidence suggests that tens of thousands of people are being deprived of their liberty without the protection of the law, and without the protection that Parliament intended.**

Worse still, in some cases the safeguards are being wilfully used to oppress individuals and to force decisions upon them. The Government needs to go back to the drawing board to draft replacement provisions that are easy to understand and implement, and in keeping with the style and ethos of the Mental Capacity Act.”

# The Court of Protection

## Alastair Pitblado, Official Solicitor to the Senior Courts

### Defender of the defenceless ?

He is allegedly described as the litigation friend of last resort

The reality is that he is often the litigation friend of first resort

Without a medical examination barrister Dominic Brazil, 1 Kings Bench Walk Chambers, had Leonard Lawrence certified under Part V11 Mental Health Act 1983 and placed under his former colleague solicitor Helen Clift, office of the Official Solicitor.

Solicitor Helen Clift did not disclose to any court the four Court of Protection Medical Certificates and the two medical reports issued under Part V11 Mental Health Act 1983 that she held. Instead Helen Clift allowed lawyers to generate over £100,000 in legal fee's

## Alastair Pitblado Official Solicitor to the Senior Courts

### 2013 Metropolitan Police, Major Crime Unit, telephone call to Leonard Lawrence

The detective informed Leonard Lawrence that there had been a request to investigate him and make life difficult for him. The detective named the Official Solicitors to the Senior Courts as the instigator.

The detective asked whether Leonard Lawrence was going to talk on radio (The Earth Needs Rebels Show) about the following: MARCH 20, 2013– GEORGETOWN UNIVERSITY MEDICAL CENTER (GUMC) researchers for the first time have discovered that veterans who suffer from “Gulf War Illness” have physical changes in their brains that may account for pain from actions as simple as putting on a shirt. Brain scans of 31 veterans with the illness, compared to 20 control subjects, revealed anomalies in the bundles of axons, also known as nerve fibers that connect brain areas involved in the processing and perception of pain and fatigue.

### 2015 Devon and Cornwall Police, Serious and Organise Crime Unit

January 2015. Devon and Cornwall Police visit Leonard Lawrence at the request of a third Police Force following the identification of offences of fraud, and other more serious offences including perjury, against Leonard Lawrence whilst he was suffering from acquired brain injury and under the guardianship of the Official Solicitor. Detective Superintendent’s Sam de Raya and Claire Armes Devon and Cornwall Police, Detective Chief Superintendent, Tim De Meyer, Thames Valley Police and Lesley Hyland Independent Police Complaints Commission (IPCC) Internal Reviewer, have unsuccessfully attempted to neutralise these offences.

## Alastair Pitblado Official Solicitor to the Senior Courts

New figures show that hundreds of parents have had the official solicitor, currently Alastair Pitblado, imposed.

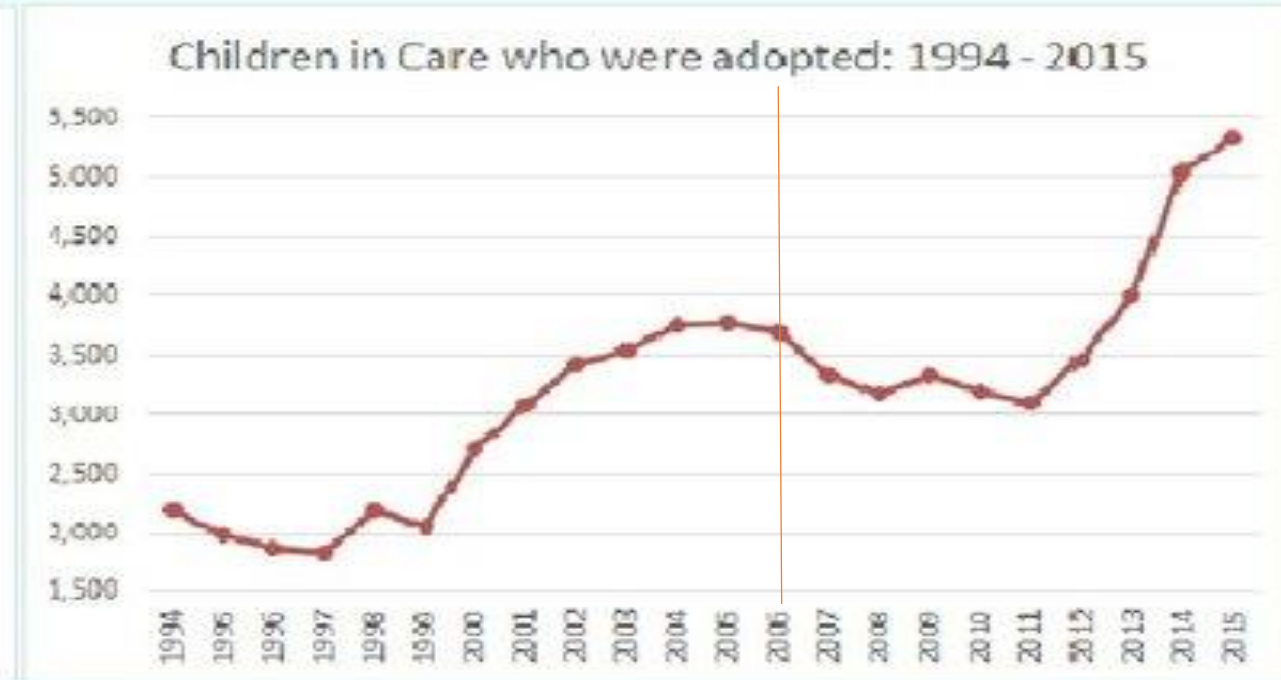
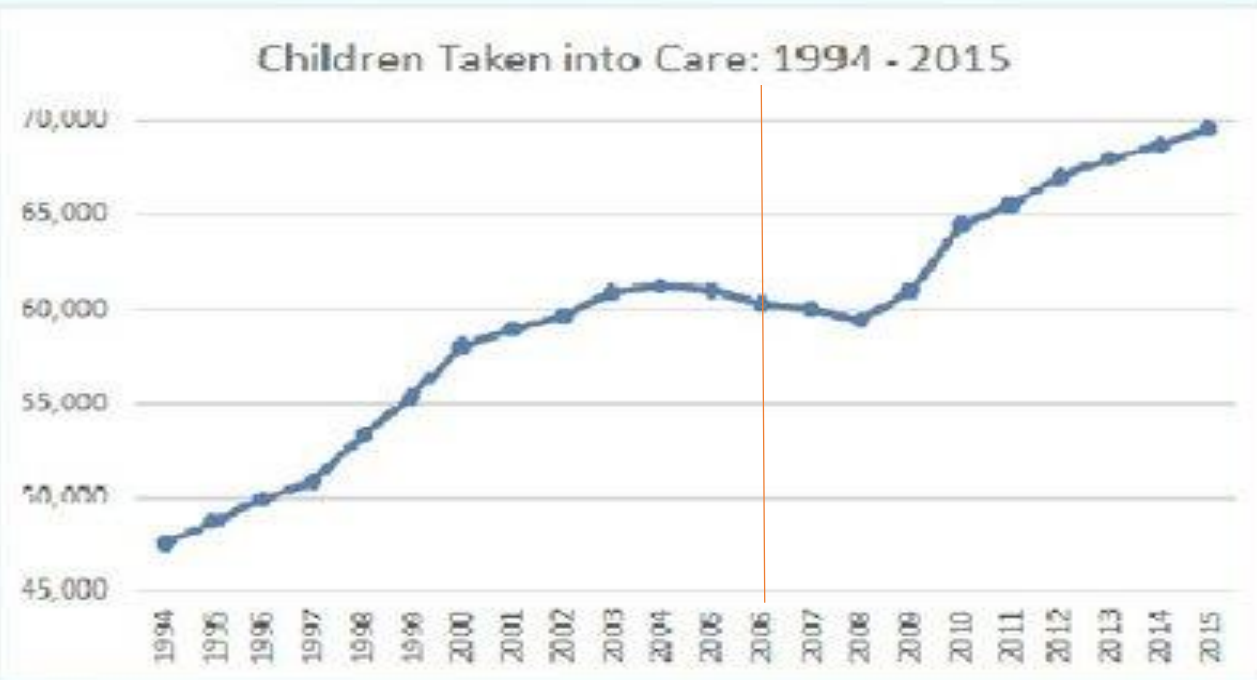

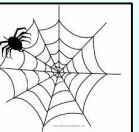

On the 29 June 2009 **Alastair Pitblado** advised the Bar Standards Board and in June 2009 **May Maughan**, The Deputy Official Solicitor, informed the Solicitors Regulatory Authority, that the point had not been reached in the Leonard Lawrence case SL03D00938 where the Court of Protection was necessary. The Official Solicitors files disclosed in March 2012 identified that Helen Clift, office of the Official Solicitor had known in 2006 that a consent order was required from the Court of Protection.

The Queens Bench Division on 3 July 2014 release a report by barrister **Caroline Willbourne**, 1 Garden Court Chambers, identifying that **Leonard Lawrence** had been incapable of legal discussion and understanding with the Official Solicitor, or any solicitor instructed by the Official Solicitor, for almost 18 months.

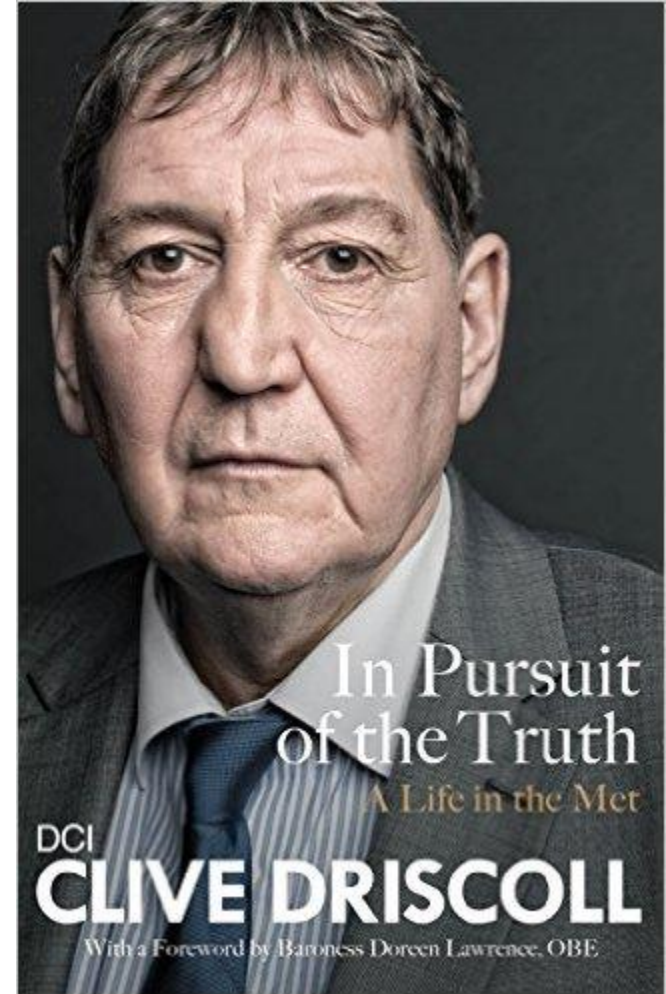

# The Court of Protection

Hospital Medical Director Report reference: Pilot Leonard Lawrence:

1. He was then medicated to the extent that he lost mental capacity.
2. During the period the Official Solicitor of the Supreme Court acted as his Guardian ad Litem, three Court of Protection medical certificates (CP3s) had been obtained but not registered with the Court of Protection.
3. He was, therefore, for nearly 18 months regarded as a mentally ill patient without access to the Court of Protection. During this time considerable amounts of his assets went missing.

How did solicitor Helen Mary Clift, office of the Office Solicitor, avoid disclosing Court of Protection Medical Certificates CP3's to the Court of Protection?

**Answer: They have No barcode, No Serial Number and therefore No Audit Trail Exists.**





# Solicitor Helen Clift, realm within the Official Solicitor Department

**Not to disclose to the Court of Protection or any other court the following:**



- Court of Protection Medical Certificates CP3's that she held for Leonard Lawrence.
- That Leonard Lawrence had an acquired brain injury from organophosphate poisoning
- That Leonard Lawrence was incapable of legal discussion and understanding
- That Helen Clift made all clinical and financial decision on Leonard Lawrence
- Allowed barrister Dominic Brazil, 1 Kings Bench Walk, her former colleague, to place adverse cost inferences on Leonard Lawrence
- Allowed solicitor Sarah Benfield to gain Leonard Lawrence signature on Legal Aid Forms whilst he was incapable of legal discussion and understanding.
- Allowed solicitors and barristers to generate over £100,000 in legal fees at Slough and Reading County Court.

- **Dominic Brazil failed to act with honesty and integrity** in that, from around the 2nd October 2014 to the 11th November 2014, **in order to mislead or attempt to mislead his chambers he concealed from his clerks the fact that he was continuing to represent his lay client.**
- **SENTENCE: 14 months suspension. Reprimanded.**
