Dear Chief Constable Of Cheshire,

Andrea Blears has blatantly shown her personal preferences and prejudice towards Mrs Dobbie and Ken Redman ahead of the children. Andrea has put her own personal likes of Mrs Dobbie, and dislike of Mr Dobbie, before the integrity of her professional status.
