Dear Sir/Madam,

- I wish to report AGAIN domestic abuse and domestic violence against my children and myself and in particular, an assault on my child ORION NOVA DOBBIE and an assault on me on the 23<sup>rd</sup> July 2010.
- 2. This was reported initially at Blacon Police Station on the 23<sup>rd</sup> July 2010, and again reported at Ellesmere Port Police Station on 24<sup>th</sup> July 2010. I was told that the Police could not investigate this or take action to protect my children as my wife had made a claim first that I had assaulted her.
- 3. After the first court hearing, I enquired with the police at Ellesmere Port Police station if they could now investigate the assaults on my children and me. The police told me on that occasion that specialist officers would follow it up.
- 4. Nobody from the police followed up from the January reporting. When I contacted by phone over a month later, I was told that the investigation into Mrs Dobbie's assaults and domestic violence had been discontinued due to it being over 6 months since the incidents. I told the police that it had been reported at the time, but the police chose not to act until my court hearing had occurred
- 5. I was convicted in the magistrates court in January on the basis of -
  - 4.1. Mrs Dobbie had been previously violent in the household.
  - 4.2. Mrs Dobbie had been attacking the child Orion Nova Dobbie.
  - 4.3. Mr Dobbie had gone to the rescue of the child.

- 4.4. Mrs Dobbie then assaulted Mr Dobbie by kicking him in the face.
- 4.5. In the opinion of the Judge, Mr Dobbie had then over reacted in his defence.
- 6. I went to the crown court with an appeal and was cleared of assault on the basis of:-
  - 5.1. Mrs Dobbie had previously been violent to the household.
  - 5.2. Mrs Dobbie had been attacking the child Orion Nova Dobbie.
  - 5.3. Mr Dobbie had gone to the rescue of the child Orion Nova Dobbie.
  - 5.4. Mrs Dobbie then assaulted Mr Dobbie by kicking him in the face.
  - 5.5. In the opinion of the Judge and two senior magistrates, Mr Dobbie had pushed Mrs Dobbie out of the way to prevent further assaults on the child and himself.
- A. I am reporting two assaults; one on my child, and one on me. Both carried out by Mrs Catherine Avril Dobbie of 38 St Asaph Road, Great Sutton, Ellesmere' Port, Cheshire, CH66 2GP on the morning of the 23<sup>rd</sup> June 2010.
- B. I am reporting the historic domestic abuse and violence carried out by Mrs Catherine Avril Dobbie of 38 St Asaph Road, Great Sutton, Ellesmere Port, Cheshire, CH66 2GP.

- C. I am making this a formal set of independent complaints to the police for the consequences of the police being NEGLIGENT in their handling of this case and the resulting failure in the duty of care to my family and me.
- D. I am making the formal complaint to the police that they deliberately put two children into harms way and significant risk through this police negligence.
- E. I am making the formal complaint that the police stopped me from protecting my children from an abusive and violent mother through this police negligence.
- F. I am making the formal complaint that the police isolated me from my home of  $\sim 15$  years and my children and my neighbours through this police negligence.
- G. I am making the formal complaint that the police isolated me from my place of work, and stopped my attending my place of work (located at the family home) with this police negligence.
- H. I am making the formal complaint that my children have suffered during the period from my isolation from them and from the controlling nature of their mother through this police negligence.
- I. I am making the formal complaint that my family was broken up for good as a result of the consequences of this police negligence.

- J. I am making the formal complaint that I have suffered mentally and financially during the period of my isolation from my children, my work, my household, my home all through this police negligence.
- K. I am making the formal complaint that my oldest son, who is terminally ill, has been isolated from his little sister and brother and has lost employment from the family company through this police negligence
- L. I am making the formal complaint that I have suffered hugely from the stigma associated with domestic violence through this police negligence.
- M. I am making the formal complaint that as a result of this police negligence, Mrs Dobbie was allowed to steal and dispose of company records (DrRheology Ltd. v is registered at the family address for over 6 years and has the administrative function there).
- N. I am making the formal complaint that as a result of police negligence, Mrs Dobbie was allowed to steal and dispose of company property of more than £7,000 value. I couldn't report it to the police at the time because your bail conditions prevented this.
- O. I am making the formal complaint that as a result of police negligence, I couldn't report to the TAX system about matters to do with tax refunds that involved Mrs Dobbie and our children and circumstances.
- P. I am making the formal complaint that as a result of police negligence, Mrs Dobbie was allowed to cancel the company internet line with resulting losses to the company.
- Q. I am making the formal complaint that as a result of police negligence, Mrs Dobbie was allowed to dispose of personal and company mail.
- R. I am making the formal complaint that as a result of police negligence, Mrs Dobbie was allowed to steal personal property of Mr Dobbie's including a £900 dvd player, a £200 telescope and others.
- S. I am making the formal complaint that as a result of this police negligence, Mrs Dobbie was allowed to steal company records for personal use and has passed these on to the CSA who are aware they are using stolen company documents.
- T. I am making the formal complaint that the police have displayed a desperately bad image of themselves to my children, my friends and my acquaintance. All of these people have lost faith in the decency of the police force all because of this police negligence and the ongoing consequences of it.

- U. I am making the formal complaint that Cheshire Police ensured the ongoing victimisation of the victims by helping an abusive and violent woman to further abuse a man and his children through this police negligence.
- V. I am making the formal complaint that Cheshire Police failed to protect my children. The sergeant at Blacon Police station was told that my children were in danger from my wife. The desk sergeant phoned my wife to ask if she and the children were ok, which she replied yes to. The sergeant then informed me the children were ok. This was negligent behaviour by the policeman in his duty of care for my children.
- W. I am making the formal complaint that Cheshire Police failed to protect my children. The sergeant at Blacon Police station was told that my children were in danger from my wife. The desk sergeant told me that the police station was now closed and that I should return in the morning. This was negligent behaviour by the policeman in his duty of care for my children.
- X. I am making the formal complaint that my company has suffered substantial losses and damage to its reputation through this police negligence.

## Notes.

- N1. There was ample evidence of my wife's abusive and violent behaviour from social services documents, witnesses, damage in the house, photographs and video. These were offered to the police at the initial time of reporting, and they declined the evidence.
- N2. My son Orion had bruises and marks around his lower neck and on his arms and legs. The police failed to examine his marks.
- N3. I have had significant problems in my face where Mrs Dobbie kicked me. The police did not carry out any medical examinations.
- N4. Can you please explain how Cheshire Police could not identify they had victimised the victim given the amount of complaints raised by the real victim (Mr Dobbie)?
- N5. Can you please explain how in 2 courts it was clear that Mrs Dobbie had a history of abuse and violence and yet Cheshire Police could not identify this?
- N6. Various IPCC's and direct complaints have previously been raised.

I report all of this in good faith and as a true and accurate version of events to the best of my knowledge and beliefs.
