

## Cheshire Child Abuse Cover Up

Dear Sergeant John Tims.

Please see below emails sent to Michael Gove, HMIC, Home Office and CPS regarding the criminal acts against my children and me.

These crimes have extensive evidence that has historically been avoided by Cheshire Police at the behest of Cheshire West and Chester council; and in particular their social workers.

DI Nigell Parr has evidenced some of the abuses of the children, but became entrenched while aligning himself with Helen Jones of social services.

Helen Jones reported to the family court under oath that the children had not been abused and that Aurora in particular had never suffered any form of sexualised assault. I have the documents from police stating Aurora was sexually assaulted by Thomas Sinnot. Aurora also reported Ken Redman handling her strongly against her wises, downloading pornography onto Aurora's tablet, pushing into Aurora's room to watch her dressing and undressing, pushing her onto the couch to look up her skirt.

When shown photographs of marks criminally left on Aurora by her mother, Helen Jones accepted Mrs Dobbie had done these but insisted I was the abuser of Mrs Dobbie because I photographed the marks on Aurora.

The evidence goes on and on and on.

There is a CAFCASS report written in 2011 about the abuses of the children. Based on that report, I had 100% custody of the children who have always been reported as desperate to live with me.

As with all hard evidence of Mrs Dobbie and Ken Redman's criminality, this CAFCASS report was subsequently avoided as hidden by social services

That I had custody of the children in 2011 drove the social workers into a frenzy of smearing, lies, perjury and harassment while taking me repeatedly to the family court. This was a spiralling web of criminality in order to cover up their negligence and criminality.

Lots of evidence.

Having gotten a judge willing to stick his neck out to cover up the child abuses, the children were moved back to Mrs Dobbie who proceeded to isolate and gag the children more.

I reported all this to the police previously, but it was badly dealt with.

Reporting it again to the police, they arrested my for harassment - by the police negligently not recognising that I was reporting crimes.

After spending time on remand in Altcourse, I was sectioned at my request to a secure psychiatric hospital at Clatterbridge. This was agreed by the psychiatrist at Altcourse, as she though my reports about the crimes against my children and me were so prolific I must be deluded. At Clatterbridge, it took them 3 weeks to report that I was not delusional or mentally ill - based on them examining me and the hardcopy evidence of the children's abuses and other crimes.

I went on trial for this supposed harassment on 9, 10, 11 and 12 March 2015 at the Crown Court in Chester. I was acquitted because I had reported crimes. The judge said he could not take action against the child abusers because they were not on trial. It was described as a mess of Biblical proportions in the way the authorities had handled all this.

Having been acquitted, I went back to Cheshire Police asking them to investigate the crimes witnessed in the Crown Court. Cheshire Police refused to investigate. John Dwyer refused to investigate. John Dwyer passed on my complaint to PPS who 1 day later replied saying that I had not seen my children in years and they were not going to investigate the child abuses as my complaint was vexatious.

Then I was arrested for Ken Redman stalking me on facebook and making an allegation to Ellesmere Port Police that I had broken a mandatory injunction that even innocent victims have imposed on them in the Crown Court after being acquitted of harassment.

This allegation proved wrong and I was still being stalked by Redman coming to 14 Old Hall Drive and looking in the window.

Then I was arrested again for Ken Redman telling the police that I had broken the injunction because he believed me to have made a sinister laugh while attending an appointment at my GP of 20 years.

So far, at least 12,000 people are guffawing at Cheshire Police for this arrest for possible sinister laughing.

Redman is , proven to have made threats to kill me previously. Cheshire police said it had nothing to do with them.

Redman is proven to have told my children he was going to get me with a baseball bat. Cheshire police said they were not interested.

Redman is photographed on two separate occasions at my previous address of 6 Coventry Avenue; threatening me, to have me assaulted, to destroy my business, to destroy my personal finances. Cheshire police said they were not interested.

Redman admitted in Crown Court to stalking me on Facebook using a false identity to know what i was saying to who.

Redman reported three times to cheshire police to have me arrested for supposed breach of bail. All three were recognised as insignificant in courts.

Redman was reported to Cheshire Police as trying to steal my property while I was being evicted from 6 Coventry Avenue. The landlord was repeatedly approached by Redman to get access to my house to remove my belongings. When I reported this to Cheshire Police, they said they were not interested.

It seems that any crime committed by Redmman against child, or person or property is personally endorsed by Cheshire Police.

DI Nigell Parr accepted Helen Jones to cover up child abuses and refuse to allow the children to be questioned.

I am asking you now, to investigate this properly.

- 18. There are tapes recording Aurora telling social workers of her abuses.

Michael Gove. Justice Secretary.

Dear Mr Gove.

Congratulations in your new job, and we look forward to some desperately needed improvements in the justice system, which we have every faith vou will bring.

I bring to your attention the most dreadful case of myself, Tom Dobbie, who having reported crimes against children, was locked up on remand in HMP Altcourse for most of 2014 on remand. I appeared before Chester Crown Court on 9, 10, 11 and 12th March 2015. I was acquitted of the charges of stalking and harassment of the children's abusers because he had indeed reported crimes.

The Crown Court judge said he could do nothing about the reported child abuse crimes because the abusers were not on trial. It was commented on during the trial that this was a mess of Biblical proportions by the authorities.

Given that I reported child abuses with copious hardcopy evidence and other witnesses available, how was it possible for police to get this confused and victimise the victims along with assisting the criminals and keeping the children in abuse?

How was it possible for the Crown Prosecution service knowing the details of the case to have assisted the criminals and kept the children in abuse

There seems to be something dreadfully wrong when police, cps and a crown court judge can all walk glibly away from having -

- 1. covered up child abuse,
- 2. assisted the abusers.
- 3. victimised the children further
- 4. and victimised the person reporting the crimes.

I am sure you can have this investigated and stop repititions of this glaring highway of assisting child abusers.

I am asking you to please investigate this situation with some urgency given the background of the industrial scale of child abuse and the industrial scale cover up of child abuse - and, the children concerned are still in abuse.

Dear Mr Gove,

Further to my email to you on June 9th, I can report a further degradation in the justice system.

On Friday morning 12th June I was arrested by Ellesmere Port Police (part of Cheshire Police) for POSSIBLY LAUGHING IN A SINISTER MANNER.

They kept me in custody, taking fingerprints, photographs, DNA, recording the interrogation, having the CPS decide if I had committed the heinous crime of possibly having a sinister laugh.

You couldn't make this idiocy up.

Having spent from 7.30am to 6pm in police custody, I was released without further action. Released to walk a considerable distance with a sore leg in order to wait for a public transport bus.

With a rolling average of over 12,000 people, my blog audience loves this stuff. This incident is just one of a large number of criminal acts assisted by, and participated in by Cheshire Police.

A major litigator involved in dealing with government corruption advised me to keep exposing at the highest level. It brings me no pleasure in reporting (with evidence) that the police here are both criminals and incompetents to a level rarely experienced even in Carry On films. I want a justice system that protects and serves - the innocent. I don't want a justice system that protects and serves criminals.

Please investigate and sort out this mess of Biblical proportions in Cheshire.

I have a large amount of clear evidence for your REAL police to examine that shows child sexual abuse, child abuse, harassment on an unbelievable scale, perjury, perverting the course of justice, theft, destruction of property, and on and on.....
