Dear Mr Dobbie,

I write in relation to a Criminal Behaviour Order (CBO) which was issued to you at Chester Crown Court on 29<sup>th</sup> September 2017 and is valid for a period of 5 years.

The order prohibits you from producing or distributing any material alleging that any member of Cheshire Police is dishonest, corrupt or engaged in criminal behavior.

Since 2012 you have been in communication with the Professional Standards Department and during this period you have sent an excessive number of emails alleging police inaction and corruption regarding allegations of child abuse.

I am satisfied those matters have been thoroughly investigated both by the Public Protection Department and the Professional Standard Department. You have been provided with an outcome of those investigations and a right of appeal.

As such I considered those matters closed.

Regrettably you continue to send excessive communication to the Professional Standards mailbox, which reiterates your allegations of police corruption and inaction regarding child abuse.

Furthermore you distribute these communications to numerous other parties.

Having sought clarity from the Crown Prosecution Service regarding your CBO, I wanted to be clear with you regarding your conduct moving forward and to be clear regarding the potential consequences of breaching your CBO.

For absolute clarity, if you continue to send or distribute communications regarding historical complaints about police corruption or dishonesty, which have already been addressed, then you will be in breach of the order and you will be liable to arrest and prosecution.

Therefore please refrain from sending communication to the Professional Standards Mailbox regarding such matters.

Dear IPCC, I was informed by you previously that IPCC could not investigate until Cheshire police and their PPS had finished with all of these matters. From the email I have just received, they have continued in their historical behaviour and relinquished their responsibility in these matters.

I suggest that IPCC and I get together to go over all of the issues involved, and to ensure you have all of the evidence in my audit trail. As my children are still forced into abuse, can you please deal with this as urgent.

Dear Clerk to Chester Crown Court, can you please pass this on to CPS and Judge Berks on.

Dear CPS, Cheshire police cannot assist in the completion of the CBO actions. They have retained the necessary laptop and tablet computer along with other equipment. Cheshire police say all matters of complaints (of which the return of these equipments is included) are now dealt with. So, no computer and tablet.

Can you please talk to Cheshire police and get them to return the tablet and laptop - and all the other stuff. Thank you.

Dear Inspector and Christopher Freeman Dean, of Cheshire police.

Yet again, in the face of hard evidence to the contrary of what you report, there has never been a satisfactory audited response of my complaints and the crimes I have reported. Multiple requests end up in silence.

At no occasion has your police force reviewed the evidence available. I have offered frequently to present the evidence to Cheshire police, who repeatedly refuse to look at it.

You are also aware that the witness Graham Dean gave evidence that was deemed so serious (witnessed by two people independent of the police) that Cheshire police videoed him. Afterwards, this evidence has never been seen or heard of again.

This is the same process by which I was unlawfully tried - by the blatant tampering of evidence to hide it. This matter is not ended as it is in appeal; a trial with no jury, no evidence and a conviction on the say so of a judge whose mistress needed me guilty.... (should be on TV)

I request a full copy of the audited investigation into all of these matters, including the responses to these reported evidenced events below. In particular, I want to see by what means the evidence is challenged.

1. the interview recordings of Graham Dean and the analysis and outcome to bury it and not talk again to him
2. the reported theft of my property by Cheshire police that was reported to me as not progressed only last week.
3. that you have investigated the threat to kill made by one of your officers to me,
4. that Cheshire police investigate the threats to kill me made by Ken Redman and found nothing even though it was reported by the children, social services, Chester County court.
5. that Cheshire police reported there were no child abuses as reported in various documents and recordings.
6. that Cheshire police are not responsible for reported theft and fraud to steal occupancy and subsequently the equity of the property I solely paid for.

7. that even though Cheshire police admitted in writing that they never investigated the original assault and child abuses by Catherine Avril Dobbie , that they consider this matter invalid as a complaint.

There is much more, and these will be put forward to the IPCC and whatever legal processes are available to get justice for my children and me.

This email from you confirms that you are now fully authorising due process to be completed by IPCC and outside of the influence of Cheshire police.

The above mentioned matters I do not expect you to investigate, as you already stated you are finished with everything, but I do expect i will receive the full audit trail of documents showing what was and was not done by Cheshire police in their version of investigating these matters.

Also, I requested all of the documents regarding my arrests and the removal of all equipment to show that you have followed due process and met all statutes.

We need to talk to CPS together, because Cheshire police still have the laptop and tablet needed to carry out the criminal acts required to meet the CBO.

I have repeatedly informed and updated police, cps and judiciary, but as usual, everyone is silent.

You threaten me that in your opinion, this CBO is a device to stop me reporting things to iCSA and at the Home Office ( inc HMIC) and the Attorney General ( Inc HMCPSI ) .

You appear to be saying you are ordering me not to report things to government departments who oversee and follow such things. Is that your belief and understanding of things ?

Cheshire police have confirmed there is no more to be said regarding them supplying the equipment they took from my flat.

They did not comply with PACE , and are now trying to force me to breaking the terms of the CBO.

Everything I have is available to you in full transparency - unlike Cheshire police.

Can you please advise where we go now as I am getting distressed and anxious and this is making my mental state worse. The police returned only some of what they took, and none which is suitable to carry out the CBO. Also, there are all sorts of severe technical issues and damage to the returned equipment which has caused me a huge amount of time to try and fix. Some I have not even been able to start on yet ( as there are missing personal files).

The importance of the last two devices they took is quite obvious as the last machines configured to gain access to the accounts and then the accounts reconfigured for these machines only for security reasons.
