Patrols attended at the address and spoke to Mya Elyce EVANS b.13/12/02 that whilst playing at a friend Aurora's (nine years old) house on Saturday 12th March 2011 at , 38 ST ASAPH ROAD, Ellesmere Port the two girls were in a bedroom with another male visiting the address known as Thomas SINNOTT (believed to be 9 years old)  
SINNOTT said to the girls, "LET'S PLAY DARES", SINNOTT said to Aurora "LETS HAVE SEX WITH

The above subject has been spoken to regarding the incident which occurred at 38 St Asaph Road, Ellesmere Port on 12<sup>th</sup> March 2011. Thomas SINNOT was spoken to in the presence of myself, DC 590 Harford, Sheena Salter (Social Worker) & Nigel Patterson (Education Psychiatrist) on Wednesday, 6<sup>th</sup> April 2011 at Maes Glas School, Greenfield.

Initially Mum would not give consent however reluctantly did so.

Thomas stated that they had visited Mum's friend in Ellesmere Port and that he knew both Aurora and Mya and that he got on alright with them. When asked what happened when he was at the address he stated that he was playing "boo" with Orian. (Orian is Aurora's Brother.) When questioned further Thomas stated that he was playing with Orian and that Orian was stopping him from coming in. When asked where he stated "The Front Door." When asked what else had happened Thomas stated that he could not remember. Thomas stated that he was not playing with Aurora or Maya at any stage. He stated that he knew that they were playing "dares." Thomas stated that he was at some stage in Aurora's bedroom but then left. Thomas stated that Orian was aged about three or four. When it was put to him that he had said to the Girls "Let's have Sex" Thomas denied this. When asked "what does sex mean?" he said that he did not know. When it was put to Thomas that he showed something to them i.e. his Penis, he replied "I HAVN'T DONE IT, DON'T KNOW WHERE THEY'VE GOT IT FROM." Thomas maintained that he did not do anything wrong in any way. He could not give a full account as to what happened whilst at the address. When questioned further he would reply by stating that he could not remember.

Thomas maintained that he had not done anything similar to or as described by the girls. He stated that he liked it at home when his Mum buys him things and takes him to different places. Thomas stated that he did not like it when his Mum shouts at him. He also stated that he did not like it when his Brother would hit him.


